FULL TERMS AND CONDITIONS OF MISS RSW BEAUTY PAGEANT 2025 – NATIONAL STAGE AUDITIONS

Read careful before you sign

Rise and Shine World Inc., Non-profit international organization headquartered in Australia has launched a beauty pageant called **Miss RSW (Miss Rise and Shine World)**. it will take place in many parts of the world to empower girls to know that the full beauty of humanity should be characterized by a love for God.

Submission of application to Miss RSW (Miss Rise and shine World) will automatically prove that you have read and agreed with all the Terms and Conditions stated below:

1. I understand that the pageant I'm registering for is Miss RSW (Miss Rise and Shine World), Open to females aged 18–30, from any country. Participants must be single (never married, no pregnant and with no children), of good moral character, and must hold a valid passport.
2. I understand that the national stage is online only. No physical auditions will be conducted. Participants are required to submit all videos and documents as stated in registration form.
3. I understand that A qualified jury team and public voting process (through www.jamglobalevents.com) will be used to evaluate contestants. Judging includes review of catwalk video, personal story, charity project, and alignment with the pageant's values.
4. I understand that the event is organized by JAM GLOBAL EVENTS in Conjunction with Rise and shine World Inc.
5. I understand that there is no required height and weight
6. I fully understand that entering the Miss RSW beauty pageant, A non-refundable registration fee of \$10 is required.
7. I understand that if I fail to comply with the entry procedure, I as a participant will be penalized with disqualification and possible lawsuit for denting the image of Miss RSW pageant title.
8. I agree that I have made all the necessary disclosures and have answered all the questions on the application form completely, correctly, and accurately.

9. I understand that if any of the information I have given is false, the organizers of Miss RSW will be entitled to exclude me from the selection process, and I will be obligated to refund the incurring cost.
10. I understand that the decision made by the Judges and Organizers will be final and binding. Therefore, no disputes in this regard will be entertained.
11. I understand that No cash or material prizes will be awarded at the National Stage. Winners from each country will proceed to the International Stage in Australia, 2026.
12. I understand that I must conduct myself in a proper manner during my stay in Miss RSW pageant if I am chosen. And I'm expected to be charming and pro-active, with high morals and respect towards organizers and peers.
13. I understand that due to the ethical and subsequent requirements for winners and contestants with health challenges, criminal record (applicant herself should be free from any criminal records) are not eligible for the competition and submission of applicant will automatically prove that I do not have any of the conditions listed here.
14. I understand that the delegate shall be a person whose background is not likely to bring into disrepute the Miss RSW or Title or the Licensee or the Promoter or any person associated with them. Entrant affirms that she is and will continue to be a person of good moral character; that she has not committed and will not commit any act inconsistent with the highest standards of public morals and conventions or that will reflect unfavorably on the pageant, its representatives, sponsors and/or licensees; that she has not appeared in, or posed for, any nude or provocative photographs prior to, during the pageant finals, or during her reign should she become a winner or Miss RSW titleholder.
15. I understand that the process and duties when selected Miss RSW requires me to be fluent in English Language or French Language, if I use any other language, I will be responsible for translator into English or French
16. I pledge that I accept these rules and I have no legal obligations which conflict with the making and signing of these Terms and Conditions in accordance with the rules.
17. I understand that the organizers are not responsible for any personal belongings. In the sense that I cannot complain about any of my belongings been missing.
18. I understand and agree that the organizers are not responsible for an accident or injury during the event. That Miss RSW, its officers, employees, and pageant personnel are not responsible for accidents, injury or theft incurred at the time of the Miss RSW Pageant or travel to and from.
19. I understand that I can never use the title for personal profit with any company, agency, institution, organization or church without written authorization.

20. I understand that I cannot use my image as Miss RSW pageant participant, slogans for any parade, event, or program without the consent of the organizers of Miss RSW pageant.
21. I agree that organizers of Miss RSW may take photographs and video footage of me and using it for the purposes of marketing and promotion of MISS RSW and its goods or services. This may include printed and digital marketing, including the use of my image on social media platforms.
22. I understand that by virtue of participation in Miss RSW, the participant agrees to allow Miss RSW the right to use her full name, likeness, voice, and/or biographical information for purposes of publicity and promotion now and in the future. Delegate understands that her name, likeness, voice, and/or biographical information may be used on the internet, in print advertising, press releases, and merchandise related to the Miss RSW (e.g., t-shirts, tote bags, hats, other apparel, mousepads, and other promotional materials.)
23. I understand that if a participant is disqualified or relinquishes, for any reason, any title awarded to her, all prizes must be returned in full, and in the condition received.
24. I understand that Delegates make their own travel arrangements. Miss RSW is not responsible for arranging travel or intervening / resolving disputes involving travel to the pageant competition. Miss RSW will cover accommodations, food and local transportation during Miss RSW international boot camp and will work collaboratively with all queens accordingly.
25. I understand that Miss RSW is not responsible for loss, theft, or damage caused to all prizes, gifts, and awards bestowed upon the entrant after these items become the property of the entrant. Entrant agrees to incur replacement and/or repair costs to lost, stolen, or damaged items including but not limited to crown/tiara, sash, plaques, trophies, etc.
26. I understand that to look solely to the Miss RSW Pageant Directors with respect to all matters relating to her application, rules, regulations, policies, preparation, rehearsal, performance and selection process, and all other matters relating to the preliminary pageant
27. I understand that the participant will conduct herself in a courteous, professional manner always during the Miss RSW Finals and while representing any Miss RSW title or titles.
28. I understand that the participant will not slander or libel other contestants, judges, Inc. Miss RSW staff, or anyone else involved with or connected to Miss RSW. Defamatory

- verbal and/or written remarks against Miss RSW. Miss RSW I Pageant will result in immediate disqualification, forfeiture of all prizes and awards won, and legal charges.
29. I understand that Any participant found publicly posting slanderous remarks on public forums will be immediately disqualified.
 30. I understand that good sportsmanship is expected at all times. Disruptive behaviour before, during, or after the pageant may result in disqualification, removal from the premises, and legal charges.
 31. All fees paid to Miss RSW are not refundable and not transferable in full or in part under any circumstances. This includes, but is not limited to sponsorship fees, voting fees, advertising fees, pageant admission fees, ticket sales fees, guest meal fees, and any other fees paid to Miss RSW by anyone including, but not limited to, participants, sponsors, fans and advertisers.
 32. I have made it clear that anyone who participates in the Miss RSW beauty pageant must adhere to the full schedule as set by the contest organizers, not arriving late or absent from any activity related to the Miss RSW beauty pageant without informing the contest organizers in advance that is automatically removed from the Miss pageant.
 33. I understand that participating in the Miss RSW pageant requires everyone to bring their own clothes, shoes, bags, and other things that the contestant needs to be able to successfully complete the competition. The contest organizers are not responsible for it; however, the organizers of the competition may provide some of the materials in the competition related to the competition such as T-shirts and others that will be given depending on the competition planned.
 34. I fully understand that selected national winners will be responsible for their visa applications. Rise and Shine World Inc. will provide some supporting documentations to support their visa applications for the hosting country and guidance, and Rise and shine world Inc will cover transportation (Return ticket) from their country to the hosting country for winners who will represent their countries to international stage . Rise and shine world Inc will also cover all costs of accommodations during their stay in hosting country.

Please note that the organizers of Miss RSW hold the right to change the "Terms and Conditions" as pertaining to the contestant in reference to Miss RSW international pageant at any given time without prior notice
