FULL TERMS AND CONDITIONS OF MRS RSW INTERNATIONAL 2025 BEAUTY PAGEANT

Read careful before you sign

This document serves as a legally binding agreement between the contestant and the organizing committee of Mrs. RSW International 2025, Organized by Rise and Shine World Inc. (RSW). By submitting an application and/or participating in the Mrs. RSW International 2025 pageant, I, the contestant, acknowledge and agree to the following terms and conditions, which will govern my participation in the competition both during and after the event. These terms and conditions apply to all contestants applying for or participating in the Mrs. RSW International 2025 beauty pageant, which is organized by Rise and Shine World Inc., a non-profit international organization headquartered in Australia. The pageant aims to empower young women globally and promotes the message that the true beauty of humanity is exemplified by a love for God.

1. Eligibility and Participation

1.1 I acknowledge that I must meet the eligibility criteria set by the organizing committee to participate in Mrs. RSW International 2025. These criteria may include, but are not limited to, nationality, age, and other requirements. The eligibility requirements will be communicated at the time of application.

1.2 I agree that my participation is contingent upon fulfilling all the requirements and conditions outlined by the Mrs. RSW International 2025 organizers.

1.3 I acknowledge that I will participate in all required activities, including events, training, rehearsals, and media engagements, as mandated by the organizing committee.

1.4 I understand that participation in Mrs. RSW International 2025 involves a global competition with international reach, and that I may be required to attend events in various countries.

2. Prizes and Rewards

2.1 **Winner's Prize, First Runner-Up, Second Runner-Up:** I understand that the winner of Mrs. RSW International 2025 will receive prizes which will be communicated contestants according to the organization

2.2 **Additional Prizes:** Other prizes may be awarded in other titles for various achievements. Depending on the way competition planned

3. Monthly Prize Payments

3.1 I fully understand that all prizes will be awarded in monthly payments based on contestants' performance and achievements during her ambassadorship period of 12 months. If I am a winner in any of these categories, I will be eligible to serve as an RSW Ambassador throughout the year. RSW has the right to pay all awards in full/half/quarter even if 12 months doesn't end depending on its decision.

4. RSW Ambassadors

4.1 I understand that all titles winners of Mrs. RSW International 2025 will automatically become RSW Ambassadors, there is no other payment than the prizes set for winners

4.2 **Ambassador Responsibilities:** If selected as an RSW Ambassador, I agree to represent the RSW brand and participate in various promotional activities, events, and initiatives, as specified by the organizing committee, for a period of one year following the competition.

5. People's Choice Award

5.1 **Public Voting:** I acknowledge that the contestant who receives the most votes in the Grand Final of Mrs. RSW International 2025, through public voting, will be awarded the People's Choice award. The People's Choice award will include a prize

5.2 All contestants competing for the title of Mrs. RSW International 2025 will participate in the vote to secure **3 spots in the Top 10** for the title they are contending for. This will happen before departure to the international stage according to the schedule of competition

6. Mrs. RSW International 2025 - Humanity

6.1 **Eligibility for Title:** I understand that all contestants will have the opportunity to compete for the title of Mrs. RSW International 2025 -Humanity through fundraising campaign.

6.2 **Humanity Winner's Prize:** I acknowledge that the winner of Mrs. RSW International Humanity 2025 will receive a prize

7. Prize Distribution

7.1 I understand that all prizes will be distributed in accordance with the timeline and instructions provided by the organizing committee. I agree to follow all official procedures to ensure I receive my prize monthly.

7.2 I acknowledge that the distribution of prizes may occur after the event has concluded, and I must comply with any documentation or verification processes required by the organizers.

8. Code of Conduct

8.1 I agree to maintain a high standard of conduct throughout my participation in the competition. I understand that any inappropriate behavior, including but not limited to, harassment, misconduct, or violation of event rules, may result in my disqualification from the competition.

8.2 I take full responsibility for my actions and behavior and agree to comply with all terms and conditions of the event, both during the competition and following its conclusion.

8.3 I commit to promoting the values of respect, equality, and unity, as these are central to the spirit of Mrs. RSW International 2025.

9. Event Modifications and Cancellations

9.1 I acknowledge that the organizing committee reserves the right to modify or cancel any aspect of the event, including dates, locations, or prize structures, at their discretion. I understand that I will be notified of any significant changes in a timely manner.

9.2 In case of unexpected events such as force majeure, natural disasters, or political instability, I agree that the organizing committee is not liable for any inconvenience or loss, and I will cooperate to adapt to changes.

10. Intellectual Property

10.1 I agree that my images, videos, and any other content produced during the competition may be used by the organizing committee for promotional purposes, including but not limited to digital media, advertisements, and event materials.

10.2 I grant the Mrs. RSW organizers the right to use my name, image, voice, and other likenesses for promotional purposes in relation to the competition, including, but not limited to, digital campaigns, print media, and television advertisements, both during and after the competition.

10.3 I understand that my participation in Mrs. RSW International 2025 may result in the creation of intellectual property, including, but not limited to, photos, videos, and written content. I consent to the use of this intellectual property by the RSW organization for marketing, promotional, and philanthropic purposes worldwide.

11. Limitation of Liability

11.1 I acknowledge that the organizing committee is not liable for any injury, loss, or damage that I may suffer during my participation in Mrs. RSW International 2025, or while attending related events before, during, or after the competition.

11.2 I agree to release Rise and Shine World Inc., its affiliates, partners, and agents from any claims of liability for injury, loss, damage, or claims arising out of my participation in the competition.

12. General Provisions

12.1 **Agreement:** By submitting my application and/or participating in Mrs. RSW International 2025, I confirm that I have read, understood, and agree to abide by all terms and conditions outlined in this document.

12.2 **Governing Law:** I understand that these terms and conditions shall be governed by the laws of the relevant jurisdiction specified by the organizing committee, and I agree to submit to the exclusive jurisdiction of the courts in that jurisdiction.

12.3 I acknowledge that the decisions made by the organizers and judges are final, and no appeals or disputes will be entertained once a decision has been made.

13. Specific Terms for Mrs. RSW International 2025

13.1 I confirm that I am participating in the Mrs. RSW International 2025 competition, which is open only to all single mothers, married women aged 18 years and above

13.2 I acknowledge that Mrs. RSW International 2025 is organized by Rise and Shine World Inc. in collaboration with JAM Global Events.

13.3 The event will take place in Adelaide - Australia as specified by the organizing committee, with further details provided in advance.

13.4 I understand that there are no height or weight requirements for participating in Mrs. RSW International 2025, and all eligible contestants will be treated equally.

13.5 I agree that there is a registration fee to participate in the competition

13.6 I understand that failure to comply with the official entry procedure may result in disqualification, and any violation could be subject to legal action.

13.7 I agree to provide accurate and truthful information on my application. If it is discovered that I have provided false or incomplete information, the organizing committee has the right to disqualify me and take legal action if necessary.

13.8 I understand that any contestant participating in the competition must not defame other participants, judges, or the organizing team. Defamation, whether in words or in writing, towards the organizers will result in immediate disqualification and the forfeiture of any prizes won, including legal action. This will be during competition or after

13.9. I understand that any contestant who defames the competition publicly during or after its completion will be immediately disqualified from the competition and may be subject to legal action.

13.10. I understand that maintaining good conduct is required at all times during the competition. Any contestant who exhibits bad behavior before, during, or after the competition will be immediately disqualified.

13.11 I agree that if at any time I am dissatisfied with any decisions made during the competition or after I have won prizes, I will submit my concerns in writing to the organizing committee, explaining my issue so that I may receive a detailed explanation, while adhering to the rules governing the competition.

13.12 I agree to comply with all instructions provided by the organizing team, and to submit any questions, suggestions, advice, or feedback related to the competition only to the organizers. I also commit to behaving in a way that upholds a positive image of the competition."

13.13 I understand that due to the ethical and subsequent requirements for winners and contestants with health challenges, criminal record (applicant herself should be free from any criminal records) are not eligible for the competition and submission of applicant will automatically prove that I do not have any of the conditions listed here.

13.14 I understand that the delegate shall be a person whose background is not likely to bring into disrepute the Mrs. RSW or Title or the Licensee or the Promoter or any person associated with them. Entrant affirms that she is and will continue to be a person of good moral character; that she has not committed and will not commit any act inconsistent with the highest standards of public morals and conventions or that will reflect unfavorably on the pageant, its representatives, sponsors and/or licensees; that she has not appeared in, or posed for, any nude or provocative photographs prior to, during the pageant finals, or during her reign should she become a winner or Mrs. RSW titleholder.

13.15 I understand that I can never use the title for personal profit with any company, agency, institution, organization or church without written authorization.

13.16 I understand that I cannot use my image as Mrs RSW pageant participant, slogans for any parade, event, or program without the consent of the organizers of Mrs RSW pageant.

13.17 I have made it clear that anyone who participates in the Mrs. RSW beauty pageant must adhere to the full schedule as set by the contest organizers, not arriving late or absent from any activity related to the Mrs RSW beauty pageant without informing the contest organizers in advance that is automatically removed from the Miss pageant.

13.18 I understand that participating in the Mrs. RSW pageant requires everyone to bring their own clothes, shoes, bags, and other things that the contestant needs to be able to successfully

complete the competition. The contest organizers are not responsible for it; however, the organizers of the competition may provide some of the materials in the competition related to the competition such as T-shirts and others that will be given depending on the competition planned.

13.18 I understand that all titles holder in Mrs. RSW must obey all regulations of the competition, for this case I agree to remain unmarried during my reign period

14. Contestant Conduct During and After the Competition

14.1 I agree to conduct myself in a professional and respectful manner at all times during the competition, and in all post-competition appearances and activities.

14.2 I understand that any behavior deemed inappropriate by the organizers or judges may result in disqualification and forfeiture of any title or prizes awarded to me.

14.3 I commit to promoting the values of the Mrs. RSW brand even after the competition ends, as an ambassador for social change and empowerment.

14.4 I agree that the consequences of any disqualification or relinquishment of my title will include the return of any prizes or awards received, in full and in their original condition.

15. Travel and Accommodation

15.1 I acknowledge that I am responsible for making my own travel arrangements to the competition hosting country unless otherwise specified by the organizing committee.

15.2 I acknowledge that I am responsible for accommodation and meals. Unless otherwise specified by the organizing committee will provide accommodation and meals during the official Mrs. RSW event, including any boot camps or official training sessions leading to the competition. And I must book my accommodation upon guidance from the Organization committee

15.3 I agree to cover the cost of any additional travel, accommodation, or personal expenses incurred outside of the official event schedule.

15.4 If international travel is required, I agree to ensure that I have the necessary visas and documentation for entry into any country associated with the event. The organizing committee will provide invitation letters and other related documents to all contestants who require a visa. All contestants are responsible for their visa cost and application

16. Mandatory Travel Insurance

16.1 I agree that it is mandatory for all contestants to have valid travel insurance for the duration of their participation in the Mrs. RSW International 2025 event.

16.2 I will provide proof of my travel insurance coverage to the organizing committee prior to traveling to the event venue.

16.3 I understand that the Mrs. RSW International 2025 organizers are not responsible for any medical or travel-related expenses incurred by me during the competition.

17. Medical Information

17.1 I agree to provide accurate and up-to-date medical information to the organizing committee prior to my participation in the event, including any allergies, medications, or medical conditions that may require special attention.

17.2 I acknowledge that the organizing committee may request a medical certificate or other relevant documents to ensure my health and safety during the event.

17.3 In case of emergency, I grant permission for the event organizers to seek medical treatment on my behalf if necessary.

18. Use of Image and Likeness

18.1 I agree that my participation in Mrs. RSW may involve the recording of my image, voice, and likeness, and I consent to the use of these materials for promotional purposes across all media channels, both during and after the event.

18.2 I grant the Mrs. RSW organizers the right to use my name, likeness, voice, and biographical information for promotional campaigns, advertisements, and any other materials related to the pageant and its sponsors.

18.3 I agree that my image, voice, and biographical details may be used in international media outlets to promote Mrs. RSW International 2025 globally.

19. Disqualification and Relinquishment of Title

19.1 I understand that if I am disqualified or voluntarily relinquish my title, I am required to return all prizes, gifts, and awards provided to me, in full and in their original condition.

19.2 I acknowledge that the disqualification or relinquishment of my title may be publicized by the organizing committee, and I will cooperate in this process.

19.3 I confirm that if I win or hold the title of Mrs. RSW, whether at the National stage or the international stage, I am not permitted to participate in any other beauty pageant or competition unless I have received written permission from the organizers of Mrs. RSW. This rule will apply during my reign period.

19.4 I confirm that there are no prizes designated for those who won at the National stage of Mrs. RSW. Therefore, I understand that I am not entitled to any prizes or rewards based on the national stage.

19.5 I acknowledge that Mrs. RSW is based on Christian values, and I agree that I should not engage in activities related to pornography, homosexuality, or any other actions that would tarnish the integrity and image of the competition. Should I be involved in any of these activities, whether during the competition or after, I understand that I will be immediately disqualified, and legal actions may be taken against me for tarnishing the image of the competition. This condition applies to me for the duration of my title, regardless of the level of the title I win as well as after"

20. Refund and Transfer Policies

20.1 All fees paid to Mrs. RSW are not refundable and not transferable in full or in part under any circumstances. This includes, but is not limited to sponsorship fees, voting fees, advertising fees, pageant admission fees, ticket sales fees, guest meal fees, and any other fees paid to Mrs. RSW by anyone including, but not limited to, participants, sponsors, fans and advertisers.

21. Changes to Terms and Conditions

21.1 I acknowledge that the organizing committee reserves the right to amend or update these Terms and Conditions at any time. All changes will be communicated to contestants promptly.
