## **FULL TERMS AND CONDITIONS OF RSW TALENT HUNT INTERNATIONAL 2025**

Submission of application to RSW Talent Hunt International will automatically prove that you have read and agreed with all the Terms and Conditions stated below:

### **General Rules and Regulations**

- I understand that the pageant I'm registering for is RSW Talent Hunt international 2025, which is for everyone feel talented or gifted for any age, any talent, and any dream
- I understand that the event is been organized by Rise and Shine World Inc. in partnership with JAM GLOBAL EVENTS
- I understand that there is no required age.
- I fully understand that entering the RSW Talent Hunt international 2025 pageant requires a **non-refundable registration fee** set by the contest organizer. Which for individual, for Group of 2-5 persons and for choir of group from 5 persons and above.
- **We recognize that ours is a unique gospel project**, and that is why it will uphold the ideals of our Christian culture and yet be able to relate in today's global system, while merging both Christian values and our modern way of life. This will be a pleasure and an honour for any contestants with a dream. I fully understand that all contents I will act in pageant will be related to the Gospel
- I understand that if I fail to comply with the entry procedure, I as a participant will be penalized with disqualification and possible lawsuit for denting the image of RSW Talent Hunt international 2025 pageant title.
- I agree that I have made all the necessary disclosures and have answered all the questions on the application form completely, correctly, and accurately.
- I understand that if any of the information I have given is false, the organizers of RSW Talent Hunt international 2025 will be entitled to exclude me from the selection process, and I will be obligated to refund for the cost incurring.
- I understand that the decision made by the Judges and Organizers will be final and binding. Therefore, no disputes in this regard will be entertained.

- I understand that the organizers are not responsible for any personal belongings. In the sense that, I cannot complain about any my belongings been missing.
- I understand and agree that the organizers are not responsible for theft incurred at the time of the RSW Talent Hunt international 2025 Pageant for travel to and from.
- I understand that I can never use the title for personal profit with any company or agency or church without written authorization. During my ambassadorship
- I understand that I cannot use my image as RSW Talent Hunt international 2025 pageant participant, slogans for any parade, event, or program without the consent of the organizers of RSW Talent Hunt international 2025
- I agree that organizers of RSW Talent Hunt international 2025 may take photographs and video footage of me and using it for the purposes of marketing and promotion of RSW Talent Hunt and its goods or services. This may include printed and digital marketing, including the use of my image on social media platforms.
- I understand that by virtue of participation in RSW Talent Hunt International, the participant agrees to allow RSW Talent Hunt the right to use his/her name, likeness, voice, and/or biographical information for purposes of publicity and promotion now and

in the future. Delegate understands that his/her name, likeness, voice, and/or biographical information may be used on the internet, in print advertising, press releases, and merchandise related to the RSW Talent Hunt (e.g., t-shirts, bags, hats, other apparel, and other promotional materials.)

- I understand that Delegates make their own travel arrangements. RSW Talent Hunt international is not responsible for arranging travel or intervening / resolving disputes involving travel to the pageant competition.
- I understand That RSW Talent Hunt international is not responsible for loss, theft, or damage caused to all prizes, gifts, and awards bestowed upon the entrant after these items become the property of the entrant. Entrant agrees to incur replacement and/or repair costs to lost, stolen, or damaged items including but not limited to awards, plaques, trophies, etc.
- I understand that to look solely to the RSW Talent Hunt international Pageant Director with respect to all matters relating to his/her application, rules, regulations, policies, preparation, rehearsal, performance and selection process, and all other matters relating to the preliminary pageant
- I understand that the participant will conduct himself/herself in a courteous, professional manner always during the RSW Talent Hunt International Finals and while representing any RSW Talent hunt title or titles.
- I understand that the participant will not slander or libel other contestants, judges, Inc. RSW Talent Hunt staff, or anyone else involved with or connected to the RSW Talent Hunt International. Defamatory verbal and/or written remarks against RSW Talent Hunt . RSW Talent Hunt International Pageant will result in immediate disqualification, forfeiture of any and all prizes and awards won, and legal charges.
- I understand that Any participant found publicly posting slanderous remarks on public forums will be immediately disqualified.
- I understand that good sportsmanship is expected at all times. Disruptive behaviour before, during, or after the pageant may result in disqualification, removal from the premises, and legal charges.
- All fees paid to RSW Talent Hunt are NOT REFUNDABLE and NOT TRANSFERABLE in full or in part under any circumstances. This includes, but is not limited to sponsorship fees, advertising fees, pageant admission fees, voting fees, ticket sales fees, guest meal fees, and any other fees paid to RSW Talent Hunt by anyone including, but not limited to, participants, sponsors, and advertisers.

- I have made it clear that anyone who participates in the RSW Talent Hunt international 2025 pageant must adhere to the full schedule as set by the contest organizers, not arriving late or absent from any activity related to the RSW Talent Hunt international 2025 pageant without informing the contest organizers in advance that is automatically removed from the RSW Talent Hunt pageant.
- I understand that participating in the RSW Talent Hunt international 2025 pageant requires everyone to bring their own clothes, shoes, bags, and other things that the contestant needs to be able to successfully complete the competition. - If international travel is required, I agree to ensure that I have the necessary visas and documentation for entry into any country associated with the event. The organizing committee will provide invitation letters and other related documents to all contestants who require a visa. All contestants are responsible for their visa cost and application
- I agree that it is mandatory for all contestants to have valid travel insurance for the duration of their participation in the RSW talent hunt International 2025 event.
- I will provide proof of my travel insurance coverage to the organizing committee prior to traveling to the event venue.
- I understand that the RSW talent hunt International 2025 organizers are not responsible for any medical or travel-related expenses incurred by me during the competition.
- I agree to provide accurate and up-to-date medical information to the organizing committee prior to my participation in the event, including any allergies, medications, or medical conditions that may require special attention.

- I acknowledge that the organizing committee may request a medical certificate or other relevant documents to ensure my health and safety during the event.
- In case of emergency, I grant permission for the event organizers to seek medical treatment on my behalf if necessary.
- I agree to conduct myself in a professional and respectful manner at all times during the competition, and in all post-competition appearances and activities.
- I understand that any behavior deemed inappropriate by the organizers or judges may result in disqualification and forfeiture of any title or prizes awarded to me.

- I agree that the consequences of any disqualification or relinquishment of my title will include the return of any prizes or awards received, in full and in their original condition.

If I am a winner in any of these categories, I will be eligible to serve as an RSW Ambassador throughout the year.
